SECURITY

FOR THE SECURITY OF TRADE CLIENT ACCOUNTS PLEASE BE ADVISED THAT THE ACCOUNT HOLDER MUST SEND A SIGNED LETTER ON COMPANY LETTERHEAD IN THE EVENT THAT ANOTHER COMPANY REPRESENTATIVE IS PURCHASING ON YOUR BEHALF.

PAYMENTS

MARC DE BERNY REQUIRES A 50% DEPOSIT UPON CONFIRMATION OF ORDER. PRODUCT CANNOT GO INTO PRODUCTION WITHOUT THE AFOREMENTIONED 50% DEPOSIT.

THE FINAL BALANCE WILL BE REQUESTED TEN (10) WEEKS AFTER THE PRODUCTION HAS COMMENCED, UNLESS OTHERWISE AGREED. THE FINAL PAYMENT WILL NEED TO BE CONFIRMED AS RECEIVED BY OUR ACCOUNTS DEPARTMENT BEFORE DELIVERY OF MERCHANDISE.

PLEASE NOTE ANY DELAY IN PAYMENT WILL DELAY DELIVERY.

THE EXCEPTION TO THIS IS PRIORITY ORDERS WHERE PAYMENT IS REQUIRED IN FULL PRIOR TO PRODUCTION COMMENCING.

LEAD TIME

MARC DE BERNY REQUIRES TWELVE (12) WEEKS LEAD TIME, FROM RECEIPT OF DEPOSIT TO COMPLETION OF THE ORDER, UNLESS OTHERWISE NOTED.

PRODUCTS WILL SHIP AFTER CONFIRMATION OF RECEIPT OF PAYMENT IN FULL.

PLEASE NOTE OUR PRODUCTION IS CLOSED FOR THE MONTH OF AUGUST, AND ALSO 2 WEEKS AT CHRISTMAS. CONSIDERING THE PREVIOUS POINT, THE LEADTIME WILL INCREASE ACCORDINGLY.

DELIVERY
